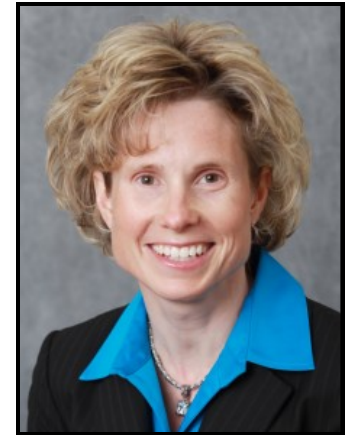

Gary Carter, CPCU - From Software Developer to Helicopter Pilot



Gary Carter, CPCU, a software developer at EMC, has returned from military leave after a deployment to Kuwait and Iraq. He served as a platoon leader, a battle captain and a medical evacuation officer-in-charge (MEDEVAC OIC) during his time overseas. Gary presented a flag and certificate to EMC President and CEO Bruce Kelley, CPCU, on Wednesday, August 12. "I flew the presented flag for EMC Insurance Companies in recognition of the unparalleled support they provided for me and my fellow soldiers," said Gary. He received a care package in December while in Kuwait and said, "I was able to

encourage my other soldiers who were spending the holidays away from their loved ones, thanks to the generosity of EMC and its employees."

Following his return, we caught up with Gary to learn more about his experience. Our questions and his responses are below.

How long have you been a member of the Guard?

I have been a member of the Iowa National Guard since 2007. While assigned as Platoon Leader to C Co 2-147th AVN, Boone, Iowa we were tasked to deploy to Kuwait in support of Operation Enduring Freedom.

How long were you deployed?

I was deployed from June 7, 2014 - April 28, 2015. However, I left work in April 2014 to conduct pre-mobilization training at Camp Dodge in Johnston, Iowa; Boone, Iowa; and Volk Field, Wisconsin. We then flew 10 UH-60 Blackhawks from Boone, Iowa to Fort Hood, Texas on June 7th to conduct our validation training and work with our Deploying Aviation Task Force. In August, we finally arrived in Kuwait to begin our mission. I returned home April 28, 2015, then had 28 days of accrued leave to use before attending the UH-60M transition course at Fort Rucker, Alabama from June 4 - July 17. After completing that course, I am now qualified to fly the new UH-60M helicopters which are arriving in Boone, Iowa throughout this year.

How did your Guard involvement impact your CPCU completion?

I started the course work for the CPCU in June 2007. I completed the last exam in December 2007 and then shipped off January 10, 2008 to Basic Training at Fort Jackson, South Carolina. I actually achieved my CPCU while training at Fort Gordon, Georgia because there was a three-year Insurance Related Experience requirement, which I did not achieve until June 2008. I then attended the designation ceremony in Philadelphia, PA the week after I returned from my Advanced Individual Training.

Gary Carter, CPCU - From Software Developer to Helicopter Pilot

What have been your responsibilities in the Guard?

From October 2011 until October 2014 I was assigned as a Platoon Leader in C Company 2-147th. I shared the responsibility of leading, training and mentoring for 22 Officers and 52 Enlisted Soldiers, and



management of 10 UH-60 Blackhawks and their required maintenance and fueling equipment. This was my primary responsibility but I also had to maintain all my proficiency and currency requirements as a helicopter pilot and crew member.

From October 2014 - December 2014 I was assigned as a Battle Captain. This meant I was responsible for the Tactical Operations Center managing all flight and support operations conducted by Task Force Shield at Camp Buehring, Kuwait. The task force consisted of MEDEVAC, Air Assault, Air Movement, Maintenance and Air Traffic Control Services. I would provide a daily update brief to the Battalion Commander, Staff and Company Commanders.

From December 2014 - February 2015 I served as the Officer in Charge of MEDEVAC operations at Baghdad Embassy Complex, Baghdad, Iraq. I managed a 24-Hour First-Up MEDEVAC team of 2 UH-60s, 13 Air Crew Members, 8 Maintenance Personnel and 4 Radio Operators. We were forward deployed to support Operation Inherent Resolve. We were replaced by active duty MEDEVAC during the last week of February.

From February 2015 - April 2015 I served as a Pilot in Command and Air Mission Commander for C Company while assisting in Platoon Leader/OIC duties at Taji Airforce Base, Taji, Iraq. We flew daily missions in central Iraq providing MEDEVAC Chase, Air Movement and Resupply for coalition forces throughout Iraq.

I am now the Assistant S-3 Air Operations for 248th Aviation Support Battalion in Boone, Iowa, where I will assist in the planning and support of flight operations for all army aviation assets in the state of Iowa.

Are there any similarities between the Guard and your desk job?

There are not a lot of similarities between what I do for EMC and my responsibilities in the Guard. But, that is why I like it so much. It helps to fill the gaps in life experiences. I work at a desk writing computer code during the day then I get to fly helicopters and train soldiers at night and on the weekends.

Burkhalter Award

The **Burkhalter Award** is presented to individuals for outstanding achievements and contributions to the insurance industry in Iowa. The impact and effect of the contribution and achievements of the recipient will be recognized and broadcasted in the community.

The **Burkhalter Award** is designed to recognize people who have made a contribution to the property and casualty insurance industry and their community through civic involvement.

The **Burkhalter Award** is named after Major General Louis D. Burkhalter, Jr. who was the first individual in Iowa to attain the CPCU designation; a charter member of the Iowa Chapter of CPCU; and the first president of the Iowa Chapter. Mr. Burkhalter had a long and distinguished career in the insurance industry, military and through his civic activities.

The fields of achievements to be evaluated include the following:

Promoting the field of insurance within the business community through civic and non-civic activities; achievements beyond primary professional responsibilities; innovation within the industry; specific achievements which benefit the industry; research efforts; volunteer work in the industry and community; and leadership activities in the governmental arena.

- Recognize outstanding service to the community and insurance industry.
- Give community visibility to the recipient and his/her achievements and contributions.
- Generate interest and motivation within the Iowa insurance industry to aspire to this award.
- Contribute to the public image and visibility of the Iowa property and casualty insurance industry.
