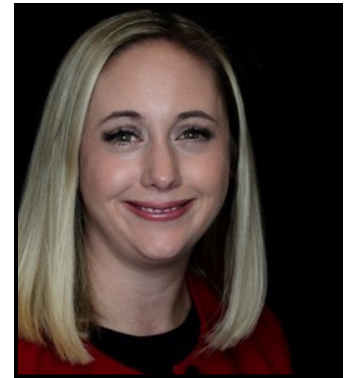
Message from the President
